The 23<sup>rd</sup> Annual General Meeting [AGM] of the Members of the Company was held on September 19, 2015, at 11.00 A.M., at the Registered Office of the Company at Plot No. T-3/2, MIDC Area, Taloja – 410208, Dist. Raigad, to transact the business mentioned in the Notice of the AGM.

In terms of the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules 2014 and the Clause 35 B of the Listing Agreement, the Company have provided e-Voting facility to the Members to vote on the Resolutions contained in the Notice of the AGM. The e-Voting was held between September 15, 2015 from 9.00 A.M. to September 17, 2015 upto 5.00 P.M. at the e-Voting website of CDSL.

At the AGM, the Company provided opportunity to the eligible shareholders to cast their votes in proportion to the shares held by them, on all Resolutions pertaining to Ordinary and Special Business as set out in items 1 to 8 of the Notice convening the said AGM.

Mr. Dinesh Kumar Deora, practicing Company Secretary [M. No. FCS 5683, COP No. 4119] was appointed as Scrutinizer to conduct the e-Voting and poll process in a fair and transparent manner. The Scrutinizer has submitted a report to the Chairman of the Company on voting results of both the process. Based on the report of the Scrutinizer, the following Resolutions have been passed with the requisite majority.
